DATA CONTROLLER

LEGAL BASIS FOR PROCESSING

This site processes data based on consent. By using or visiting this site, visitors and users explicitly accept this privacy policy and consent to the processing of their personal data according to the methods and purposes described below.

TYPES OF DATA PROCESSED AND PURPOSES OF PROCESSING

a) Browsing data

During normal operation, the IT systems and software procedures responsible for running this website acquire certain personal data the transmission of which is standard when using internet communication protocols.

This category of data includes IP addresses or domain names of computers and terminals used by the users, the URI/URL (Uniform Resource Identifier/Locator) addresses of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file received in response, the numerical code indicating the server response status (success, error, etc.) and other parameters relating to the operating system and the user's IT environment.

Such data, required to avail of the web services, are also processed for the purposes of:

- obtaining statistical information on the use of the services (most-visited pages, number of visitors per hour/day, geographical location of origin, etc.);
- checking that the services offered are working properly.

Browsing data is not stored for more than seven days (unless otherwise required by legal authorities for the purposes of investigating alleged offences).

b) Data provided by the user and handling contact request responses:

Data provided freely by the User via the contact "form", or by e-mail, will be processed for the purposes of handling the data subjects' requests.

Users may consent to the processing of their Personal Data to allow the Controller to handle and respond to requests concerning products and/or company initiatives, or regarding the Site ("contact" section of the Site). For such purposes, the user's consent is required at the time of submitting the request. If the user does not consent to the processing of their Personal Data for such purposes, it will not be possible to submit a request.

c) marketing activities:

If the visitor provides their explicit, freely given consent, the data obtained may be processed for commercial, promotional, informational and statistical purposes, as well as to identify potential customers using both online tools (e.g. newsletters, e-mail, etc.) and other means (hard copy, multimedia, etc.)

Personal data may also be processed for marketing purposes, specifically associated with supplying the requested products (for example: requesting information, registering with the website to view products, get quotes, etc.).

The Controller will also process the data for statistical analysis purposes, in anonymous form.

Processing will be performed using electronic methods and the data will be stored on the Controller's server.

PROCESSING PERIOD

RECIPIENTS

The User can freely modify the information he or she enters in the "form" (including his or her e-mail address). Such information may be disclosed to an external company that acts as external Data Processor and that supports the Controller in managing the website and handling your request.



The Personal Data may be disclosed to and/or processed by:

- Legal or natural persons acting as external data processors, to whom tasks have been outsourced by the Controller or external data processors appointed by *S.C.M. Tecnologie S.r.l.* (including persons tasked with support, communication, marketing, advertising, promotional and sales activities for the products and/or services, as well as advertisers, advertising brokers, IT service providers, Website managers, electronic platform managers, partners, credit institutions and professional firms);
- The Controller's employees and/or collaborators (including system administrators) who, working under the direct authority of the latter, are authorised to process the Personal Data;
- Employees and/or collaborators of external data processors (including system administrators) who, working under the direct authority of the external data processors, are authorised to process the User's Personal Data.

The User's Personal Data will not be sent or disclosed to third parties unless *S.C.M. Tecnologie S.r.l.* is required to disclose such data to consultants for the purposes of protecting its rights.

RIGHTS OF THE DATA SUBJECT

Data subjects are reminded that they have the right, at any time:

- to obtain confirmation from the Controller as to the existence of processing concerning their Personal Data, even if such data has not yet been recorded, and to receive such data in an intelligible form, and to access the Personal Data (and receive a copy of it) and the relevant information (including purposes of the processing, categories and source of the Personal Data, categories of recipients to whom they have or may be disclosed, storage period (if possible) and the rights that may be exercised);
- to demand that the Controller rectify their Personal Data and complete any incomplete data;
- to delete their personal profile from the Site, and demand that the Controller erase the relevant Personal Data without undue delay if, among other reasons, the Personal Data are no longer required for the purposes for which they were processed, or the legal basis for their processing no longer applies
- to withdraw consent to processing of their Personal Data for any of the purposes for which it was granted.
- to demand that the Controller anonymise or block Personal Data processed in breach of the law, including Personal Data that does not need to be stored for the purposes for which they were collected or subsequently processed
